1. **Fall/Spring: Thursday class** (Parent/Child Playgroup, **for ages 0-2**) 10am–12pm Cost \$205/semester
2. **Fall/Spring: Thursday class** (Preschool, no parent attendance **for ages 3-4**) 10am–12pm Cost \$205/semester
3. **Fall/Spring: Saturday class** (Parent/Child Playgroup, **for ages 0-2**) 10am–12 Cost \$130/semester
4. **Fall/Spring: Saturday class** (Preschool, no parent attendance, no diapers) **for ages 3-4**) 10am–12 Cost \$130/semester
5. **Fall/Spring: Saturday class** (**Ages 5-12**, no parent attendance. Children will be placed in specific class according to age and class sizes) 10am–1:30pm Cost \$185/semester

Fall semester: Alternate Saturdays: September 9, – December 16, 2017

Spring semester: Alternate Saturdays: January 13, - May 19, 2018

Policy:

- **The Fall term registration with non- refundable payment is due by May 31th, 2017. The Spring term registration with non- refundable payment is due by December 31st, 2017.** Students are enrolled once full payment is received. If enrollment exceeds capacity, students will be placed on a waiting list. Payment for students on the waiting list is only required once space opens up for them. A late fee of \$25 for currently registered families will be assessed per student if payment is received after due date. Tuition may be paid by PayPal (see our website) or by checks payable to **Finnish School of Seattle**. - The space is limited in our classes (ratio 1/12). We fill our classes on a first-come, first served basis. Based on enrollment, we reserve the right to alter the schedule and tuition. We also reserve the right to review our policies on a case-by-case basis.
- Children born and registered mid-semester are not required to pay FULL tuition for that semester. The tuition will be prorated.
- The sibling discount will be implemented as follows: Full tuition for the 1st and 2nd child. A 50% discount is applied beginning with the 3rd child according to the group-specific fee schedule.
- The Finnish School of Seattle follows the Lake Washington School District's snow or storm closures. One make up day will be available for both the Thursday and Saturday classes if classes are cancelled due to inclement weather.

RELEASE FORM

Release of all rights against the *Seattlen Suomi Koulu/Finnish School of Seattle* (hereinafter *Seattlen Suomi Koulu*) and those working or volunteering for *Seattlen Suomi Koulu*; Agreement to Rely Only on Your Own Insurance in Case of Accident or Damage to Property; Authorization to Administer First Aid or Emergency Medical Treatment to Children.

Release executed on (MMDDYY) _____, by (NAME) _____ in the County of _____ Washington, here referred to as releaser. Release executed to *Seattlen Suomi Koulu*, a nonprofit Washington corporation located at 7305 208th Ave NE, Redmond, WA 98053, here referred to as release.

I, releaser, being of lawful age, in consideration of both myself and my child(ren) being permitted to participate in *Seattlen Suomi Koulu*, do for myself, my spouse, my child(ren), my heirs, executors, successors and assigns hereby release and forever discharge *Seattlen Suomi Koulu*, including without limitation its officers, agents, employees, independent contractors, temporary employees, volunteers, successors and assigns, of and from any and every legal claim, demand, action or right of action, of whatever kind of nature either in law or in equity arising from or by reason of any bodily injury or personal injuries, death or property damage resulting or to result from any accident or misfortune that may occur as a result of my participation, my spouse's participation, or my children's participation in *Seattlen Suomi Koulu*, or resulting from any activity in connection with *Seattlen Suomi Koulu*, whether resulting by negligence or otherwise.

I further release all officers, directors, teachers, agents, employees, contractors, temporary employees, and volunteers, connected or related to *Seattlen Suomi Koulu* from any claim whatsoever on account of first aid, treatment or service rendered to me, my spouse or my children as a result of participation in *Seattlen Suomi Koulu*. I authorize any and all emergency or first aid treatment for my children that may be deemed necessary by *Seattlen Suomi Koulu*, including those acting on *Seattlen Suomi Koulu's* behalf (as identified above), in its sole discretion.

I hereby swear and warrant that I am the legal parent or guardian of the above named children, and that I have full authority to enter into this release and to authorize emergency medical treatment on their behalf. I agree that myself and my children shall personally assume all risks in connection with *Seattlen Suomi Koulu* activities, including all risks connected therewith, whether presently foreseen or not foreseen, and further to save and hold harmless the *Seattlen Suomi Koulu* and all persons connected therewith in accordance with the next paragraph.

Releaser, in his or her individual capacity on behalf of their spouse and on behalf of their minor children named above hereby expressly stipulates and agrees, in consideration of participation in the activities of the *Seattlen Suomi Koulu* school as well as participation at a price significantly lower than would be possible without this release to keep and obtain insurance against property damage, accidental injury and death as the sole source if compensation for injuries of any kind that may be sustained as a result of participation herein.

Releaser also stipulates and agrees to indemnify and hold harmless *Seattlen Suomi Koulu*, including without limitation its officers, agents, employees, independent contractors, temporary employees, volunteers, successors and assigns, from any further claims or demands that may subsequently be brought by the minor or by any other person or persons on account of damages of any character resulting in any way from incidents involving the children or minors described above. Releaser further agrees to reimburse and make good to releasee any loss, damages or costs that releasee may have to pay as a result of any such action, claim or demand made on behalf of my children, my spouse or myself. This release contains the entire agreement between the parties hereto and the terms of this release are contractual and not a mere recital.

As releaser, I further state that I have carefully read the foregoing release, know the contents thereof, am competent to understand the English language contained in legal instruments, and that I sign this release as my own free act.

If any part of this release shall be deemed invalid for any reason, the invalid portion shall be stricken, and the rest of this release be given full force and effect. I understand that this release is to be given the broadest possible construction under Washington law.
